

Full Course Contract Agreement All Pass Driving School Stouffville Location

PARENTAL APPROVAL All Pass Driving School LTD requires parental approval if the Student Driver is under 18 years old and if the payee is parent/ Guardian

Conditions: I hereby give my consent for my child to take Driver's education with All Pass Driving School .I understands that the Driving Instructors have Special Training and hold a valid Ontario Driving Instructor License required by Law. I also understand the vehicles are equipped with Dual Brake System as required by Law. I understand and agree that my child is using Driving Instructor vehicle during all driving lessons.

IN-CLASS REQUIRMENTS

1. Students are required to have "access" to the online version or a physical copy of the "Official Driver's Handbook" as a reference while attending any MTO –Approved BDE Driving School Course.
2. In-Class attendance is Mandatory .In order to complete the MTO Approved BDE Course, you must complete 20 hours of Classroom training Split into 4 multiple days 5 Hours each day, the course also contains 10 Hours of Home Links if you are absent from a class, you must make up the missed class on the next course offered , In-Class hours must be completed in Order of 1,2,3,4 Sessions ,
3. MTO Approved BDE Course requires you to complete minimum 40 Hours of Driver Training 20 Hours In-Class 10 Hours of In-Car + 10 Hours of Home Links
4. **If MTO Beginner Training is not completed within Maximum 12 months (One year) from the first Registration date, the course will be expired and all driving lessons & Road test packages will be forfeited, therefor students who DO NOT complete the 20h In-Class & 10H of In-Car lessons within Maximum 12 months period will be required to redo the entire MTO BDE COURSE. This policy is a MTO (Ministry of Transportation) Regulation and is stated in the Highway Traffic Act, as Law**

IN-CAR DRIVING POLICY

1. All Driving lessons are One-on-One Driver Training 100% private this means Only Driving Instructor and Student Driver are in the vehicle
2. Driving lessons must be pre-scheduled by "TEXTING ONLY " between Driving Instructor, Student Driver you can book 1 or maximum 2 hour Driving lesson per each calendar day, (Driving Instructors are NOT allowed to schedule driving lessons over the phone since it may cause confusion so **please text only**)
3. Student driver must complete all 20 hours of In-Class and Pass Final In-Class Examination before starting In-Car Driving Lessons
4. **Driving lessons Pick & Drop will be from your home, school ,work within Stouffville Only , We DO NOT provide driving lessons to Expected Mothers**
5. In-Car Driving lessons must be completed within Maximum 4-months from starting point ,you cannot pro-long driving lessons longer than 120 days
6. We highly recommend to start your driving lessons 4-5 months prior your G2 Road Test eligibility (this is to make sure you complete all driving lessons and get Certification process completed by All Pass Driving on time this way you should be able to book your G2 Road Test faster ,booking G2 takes up to 60days with Drive Test ,(All Students must notify their In-Car Instructor first before booking their G2 Road Test)
7. We expect all parents/student drivers to contact All Pass Driving School office immediately within Maximum 24 hours or first business day of issues, problems, or cancellations in relation to the Driving Instructors by calling All Pass Management at 416-953-7277 (always leave a message if no answer)

IN-CAR CANCELLATIONS.

1. If you have to cancel a driving lesson for any reason ,you must "text" you're driving instructor at least 24 hours before the start of your driving lessons, otherwise **you will be required to pay \$55.00 +HST per each hour you missed for .i.e. a 2 Hour driving lessons will have a cancellation fee of \$110.00+HST** Please be responsible, and mindful that the driving instructors scheduled time is valuable ,like any other profession, The MTO Ministry of Transportation requires student Driver to complete minimum 10 hours of In-Car training any late driving lessons will NOT be counted.

MTO CERTIFICATION.

1. All 20 hours of classroom training and 10 hours of In-Car driving lessons+ 10 hours of Home links must be completed before we process your certification

2. You must Email us your final Driver Evaluation to allpassconfirm@gmail.com this evaluation report will be completed by driving Instructor on the final or 10th In-Car driving lesson and will be given to student driver to take home, student driver must present it to parents/Guardian to review and sign prior scanning/taking picture and emailing back to All Pass Driving School once we receive this evaluation report it will take 1-3 business days to process your certification, then you will receive a confirmation email back from All Pass Driving that **“you are now certified”** at this point you can visit www.drivetest.ca to book your G2 Road Test(it could take up to 60 days to schedule your G2 appointment always notify Instructor before booking G2)
3. If you have Silver, Gold & Diamond program with All Pass Driving School, you must notify you're Driving Instructor prior booking your G2 to make sure His/hers vehicle is available to be used for Road Test.(Bronze Package applicants must book & provide own car for G2 Road Test)
4. Once you pass your G2 you should (Student Driver) visit in person to any Service Ontario office near you to request a copy of **“Driver License History”** costs \$12.00 this document required & accepted by most Insurance companies as a proof of Driver education completion

By checking off the online registration I the parent /Guardian & Student Driver, certify that the statements in this document are accurate and I have read and understood all the above conditions and further agree to comply with them and consent to the release of any information contained herein to the Ministry of Transportation, Insurance Bureau of Canada, and MTO Course Inspectors.
